I am pleased to present the Report on the **POSTAL BALLOT** conducted by the Company to pass Special Resolution as contained in the Notice of Postal Ballot dated **August 23, 2018**.

- 1. In terms of Provisions of Section 110 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014, I was appointed as Scrutinizer by the Company to conduct the Postal Ballot as contained in the Notice dated **August 23, 2018**.
- 2. Members approval sought for:

Buyback of 6,00,00,000 Equity Shares or higher of the Company from all the equity shareholders on a proportionate basis through "Tender Offer" route under the Securities and Exchange Board of India (Buyback of Securities) Regulations, 1998 at a maximum price of Rs.1500 per equity share aggregating to Rs.9000 Crore.

- On the basis of the Register of Members and the List of Beneficiary Owners made available by the Depositories viz., National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL), as on August 24, 2018 (cut-off date), the Company completed dispatch of the Notice of Postal Ballot:
  - On 30<sup>th</sup> August 2018, by email to 7,21,393 members who had registered their email-ids with the Company/ Depositories.
  - > On 28<sup>th</sup> August 2018, in physical form by Speed Post to 582 members.
  - On 28<sup>th</sup> August 2018, in physical form by registered post to 12,643 members.
  - On 29<sup>th</sup> and 30<sup>th</sup> August 2018, in physical form by courier to 2,40,832 members.





- 4. In terms of the aforesaid Notice, members were required to convey their assent or dissent, as the case may be, as under:
  - In case of Postal Ballot Form mailed to them by the Company, in postage pre-paid envelopes addressed to me on or before close of working hours at 5:00 p.m. on Monday, October 1, 2018.
  - In case of remote e-Voting, votes to be cast electronically on remote e-Voting platform provided by Karvy Computershare Private Limited (Karvy) till 5:00 p.m. on Monday, October 1, 2018.
- 5. I received **1,017** Postal Ballot Forms and **2,526** Members cast their votes on the remote e-Voting platform, till **5:00 p.m. on Monday, October 1, 2018**.
- 6. With the support of Karvy, the Registrar & Transfer Agents (RTA) of the Company, the Postal Ballot Forms were scrutinized and signatures of Members were verified with their specimen signatures registered with the RTA and as provided by the Depositories.
- In case of remote e-Voting, Members' demographic details, their voting rights and voting pattern were provided to RTA.
- The votes, if any, cast by a member(s) both in Postal Ballot Form and remote e-Voting having been identified, votes cast through remote-Voting only were considered valid.
- After the aforesaid scrutiny of Postal Ballot Forms and taking into account the remote e-Voting result, I report that the Special Resolution as contained in the Postal Ballot Notice dated August 23, 2018 has been passed with requisite majority.
